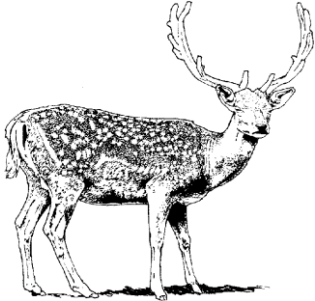

WHAT HAPPENS NEXT: Once the date and the leaders are confirmed you will be sent an invoice. Invoices must be paid **BEFORE** the visit takes place or **ON THE DAY** at the latest.

WHAT IS ON SITE: The Forest Centre provides an excellent base for your visit. The Education Barn is somewhere to store your things, a place to work and eat lunch if it's too wet or cold outside. The Education Barn will be locked to ensure security when outdoor activities are taking place and keys will be made available. There are toilets and hand washing facilities adjacent to the barn.

WHAT TO WEAR: Activities will continue irrespective of the weather except in extreme conditions. Please come dressed appropriately for the weather on the day. In winter all visitors will need warm clothes, waterproof coats and trousers if possible and stout shoes/ wellies. In summer you will need hats, sun screen and extra water to take on site. Children and staff need to wear stout closed toe shoes/boots and long trousers for all visits, whatever the time of year.

LITTER: There are no litter bins on the Ashdown Forest and we do not have facilities to collect waste from children's lunch boxes, except fruit and vegetables for composting. Please note children will need to take all litter home with them for recycling or disposal. Please talk to the children before the visit about keeping waste to a minimum to help protect the environment.

COACH PARKING: Free minibus parking is available at the Forest Centre. Broadstone car park should be used by larger coaches and the Forest Centre is a clearly signposted a short walk away. Coaches must not pull into the Forest Centre yard as this is used by heavy machinery and is unsafe for members of the public.

INSURANCE: Talking Trees and The Conservators of Ashdown Forest have their own public liability insurances. Schools should ensure they have their own appropriate insurance for their pupils/children when engaged in activities on the Forest. Staff in charge of the educational parties are fully responsible for the conduct of all members of their party during the visit. School staff are also responsible for First Aid whilst on the Forest.
